SUBJECT: Monthly Reports of the Indian Political Agent at Lhasa, Tibet.

The Department's airgram under reference indicates that the Department is interested in continuing to receive copies of the monthly reports of the Indian Political Agent at Lhasa if these can still be obtained by this office from the Deputy High Commissioner for the United Kingdom in Calcutta, even though summaries of the same reports are being forwarded to the Department by the Embassy in London.

On several occasions in recent months when talking to Mr. L. J. L. Addison, the British Deputy High Commissioner, I have referred to our continuing interest in seeing these reports, but I am informed by him that they are no longer received by his office. It therefore appears that the Department will have to continue relying upon the Embassy in London for the receipt of this information. In this connection, the Consulate General has read with interest the summary of the report of the Indian Agent at Lhasa for the period ending April 15, 1952, which was transmitted to the Department by the Embassy at London with its despatch No. 6165 of June 27, 1952. For the Department's information, the last report which we received from the British Deputy High Commissioner and transmitted to the Department was for the period ended December 15, 1951 (see our despatch No. 372 of January 31, 1952).
