The Embassy is pleased to note that the copies of Nepalese reports on Tibet that have been transmitted to the Department have been considered useful. The Embassy expects to obtain similar data on a regular basis.

The Embassy understands the Government of Nepal makes available such reports to other governments with whom it has relations. These are India, UK, France and US.

In response to the Department's request for Embassy views on making available selected studies on World Communism and developments in China, the Embassy has informally approached Nepalese representatives on the subject. The Nepalese Embassy in New Delhi has indicated that the Government of Nepal would be happy to receive such data.
