Stalin replied that on his return trip from Tehran he had flown at 4000 meters and that it had taken him several weeks to recover from an ear illness incurred on this trip. Stalin remarked that the Prime Minister was the healthiest old man -a "desperate fellow". I said that the Prime Minister was using all his energies to defeat Hitler. After that he would not care what happened. The British Ambassador remarked that Mr. Churchill would never rest until the Japanese were beaten.
