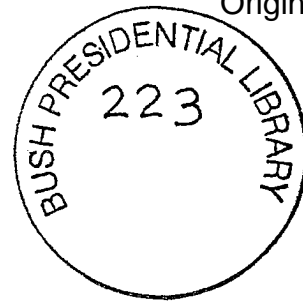

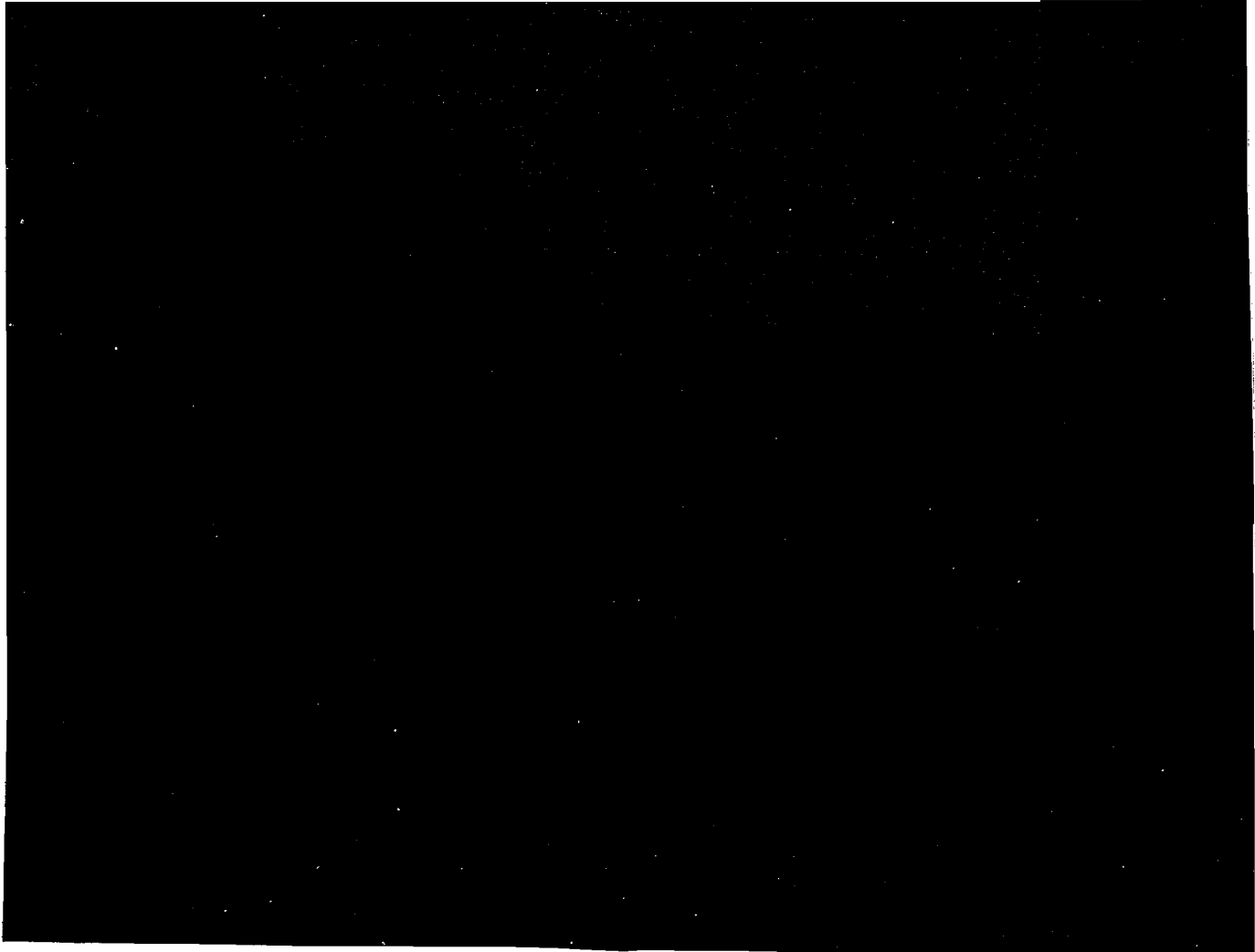

Chancellor Kohl: George, let's do it that way. Either I will call personally or one of my staff will call your staff. (U)

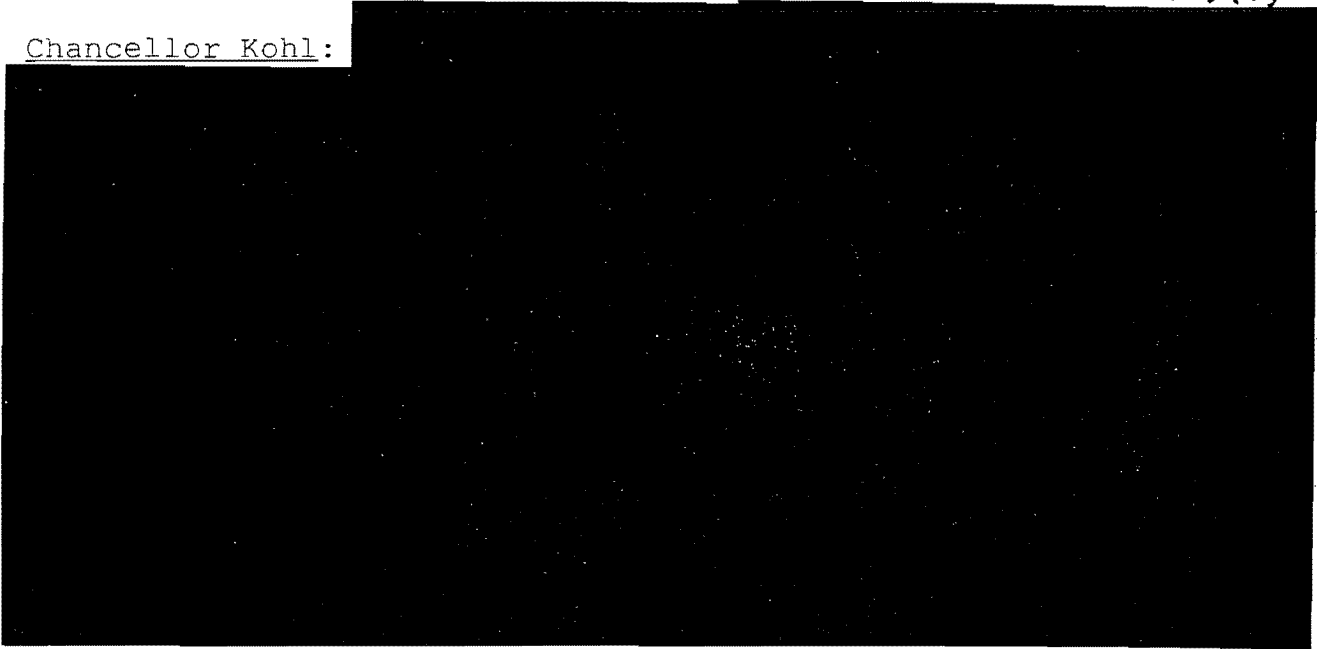

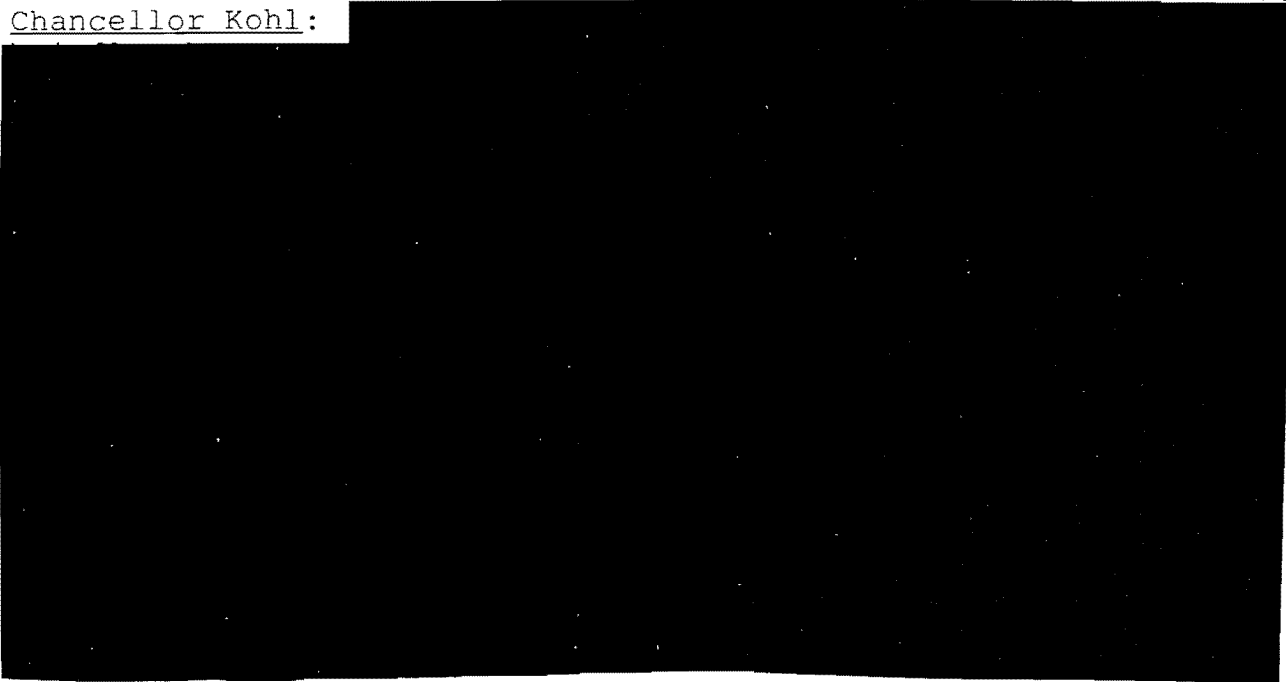

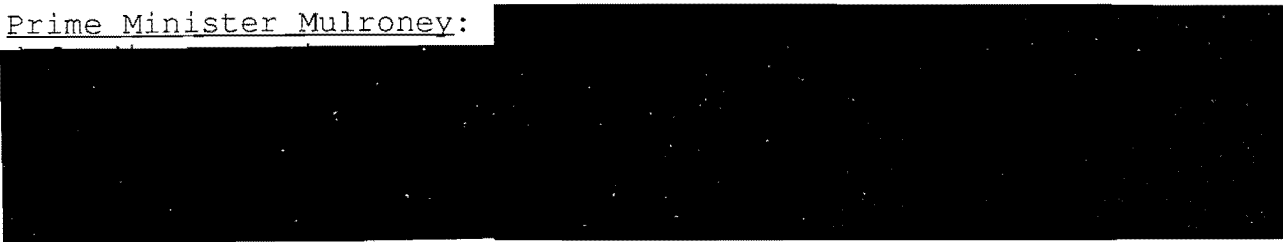
