Foreign Office rejected language first paragraph reference telegram because phrase "enter into force provisionally" has no meaning under Turk juridical concepts and in fact is practically untranslatable, but GOT has agreed to language given in second paragraph. With this amendment Embassy proposes proceed with exchange of notes Monday April 8.

Ambassador expressly confirmed with Foreign Minister Erkin April 4 that all concerned recognize dismantling begins April 15 and this reconfirmed as agreed understanding at working level today.
