1. LETTER OF INTRODUCTION RECEIVED 7 OCT. HEADQUARTERS OFFICER MET SUBJECT'S BROTHER 9 OCT. BROTHER AGREED TO COOPERATE AND WILLING TRAVEL MEXICO INTRODUCE SUBJECT KUBARK OFFICER. PRIME AIM WOULD BE RECRUIT FOR MAINLAND RESIDENT ASSIGNMENT BUT WOULD AT MINIMUM HOPE DERRIVE ON MAINLAND EXPERIENCE.

2. BROTHER EMPLOYED GEOLOGICAL SURVEY, DEPARTMENT OF INTERIOR, LOS WASHINGTON. FAMILY STILL RESIDING RIVERSON. SUBJECT WROTE HIM FROM CANTON 12 SEPTEMBER. WIFE RIVERSON FORWARDED LETTER WASHINGTON. SUBJECT SAID VISITED HAWAII AND MEXICO CITY. EXPECTED FROM MEXICO DEPT. ABOUT 20 ( ) GAVE ADDRESS AS CARE OF SOLIMED DE AGRI. TERRES MEXICANAS, COMITE ORGANIZADOR UJA, AV VESPERAS #7 24. INDICATED WOULD ATTEMPT CONTACT BROTHER BY TELEPHONE. BROTHER IN WASHINGTON. WIFE RIVERSON WILL GIVE HIM BROTHER'S WASHINGTON PHONE NO IF HE CALLS AND BROTHER HAS AGREED ASK SUBJECT EXACTLY WHERE STAYING MEXICO AND INDICATE MAY BE POSSIBLE FOR HIM VISIT SUBJECT.

3. BROTHER DESCRIBED SUBJECT AS APOLITICAL, INTERESTED ONLY IN TEACHING ALTHOUGH POSSIBLY CUB MEMBER BECAUSE OF POSITION

4. SUBJECT STUDIED PARIS OBTAINED ADVANCE DEGREE URBAN  
DESIGN AND ARCHITECTURE. AS THESIS FOR ARCHITECTURE STUDIES  
DESIGNED UNIVERSITY CITY OF PEKING WHICH WON FIRST PRIZE FOR  
ARCHITECTURAL COMPETITION THAT YEAR FRANCE. AFTER GRADUATION  
WORKED SHORT TIME FRANCE THEN RETURNED PEKING GET MARRIED.

FEBRUARY 1963 LEAVING SUBJECT AND OTHER CHILDREN SEVERAL HOUSES AND PLOTS LAND PEKING. IN RECENT CORRESPONDENCE SUBJECT ATTEMPTING WORK OUT METHOD OF DISPOSING PROPERTY. ALTHOUGH THEY CORRESPOND REGULARLY, BROTHER HAS NOT SEEN SUBJECT FOR THIRTY YEARS AND LOOKING FORWARD TO POSSIBILITY MEETING MEXICO. 7. DEPARTMENT OF INTERIOR HAS AGREED PERMIT SUBJECT TRAVEL MEXICO OUR EXPENSE. SUBJECT WILLING ASK DEPART SOONEST. PLEASE ADVISE STATUS <sup>of</sup> STICAL-1 OP, WHETHER OR NOT YOU FEEL THAT TRAVEL BY BROTHER WOULD OVER-COMPLICATE. IF NOT WHEN BEST FOR BROTHER TRAVEL, WOULD YOU NEED ADDITIONAL TDY HELP.
