ROBATEL SLPI (ADDRESS: RUE DE GENEVE, 8.P. 20, 69740 GENAS, FRANCE) IS INVOLVED IN THE SUPPLY OF HOT CELLS AND LABS, GLOVE BOXES, SHIELDED CONTAINERS, AND DECONTAMINATION EQUIPMENT. IN ADDITION, A SCIENTIFIC AMERICAN ARTICLE ON REPROCESSING THAT APPEARED IN DECEMBER 1976 REPORTS THAT AN AXIAL-FLOW, MULTISTAGE CENTRIFUGAL CONTACTOR CALLED THE ROBATEL HAS BEEN DEVELOPED BY SAINT-GOBAIN TECHNIQUES NOUVELLES AS AN IMPROVEMENT OVER EXTRACTION COLUMNS AND MIXER SETTLERS.

3. IT WOULD BE PARTICULARLY USEFUL IF EMBASSY COULD ASCERTAIN IF THE CENTRIFUGES REFERRED TO IN THE LE POINT ARTICLE ARE THOSE USED TO HELP CLARIFY THE PROCESS STREAM AFTER DISSOLUTION OF THE SPENT FUEL, OR IF THE ARTICLE

IS REFERRING TO THE MORE CRITICAL CENTRIFUGAL CONTACTORS. IN EITHER CASE, DEPT WOULD BE INTERESTED TO LEARN IF AND WHEN THE EXPORT LICENSE FOR THIS EQUIPMENT WAS ISSUED, AND WHETHER THE CENTRIFUGES HAVE BEEN SHIPPED OR WHEN THEY ARE SCHEDULED FOR SHIPMENT.

4. DEPARTMENT IS OF COURSE AWARE OF THE SENSITIVITIES THAT RELATE TO THE WHOLE SUBJECT OF THE PAKISTANI RE--PROCESSING SALE. HOWEVER THIS INFORMATION APPEARS TO BE OF SUFFICIENT IMPORTANCE TO JUSTIFY EMBASSY'S DISCREET INDUIRY. VANCE
