SUBJECT: IAEA SAFEGUARDS IN PAKISTAN

1. RECENT ACTIONS BY PAKISTAN HAVE GENERATED CONCERN AT HIGHEST USG LEVELS REGARDING THE INTENTIONS OF THAT GOVERNMENT IN ITS ATOMIC ENERGY ACTIVITIES. DR. NYE HAD AN OPPORTUNITY RECENTLY TO DISCUSS WITH IAEA DIRECTOR GENERAL EKLUND SOME ASPECTS OF OUR CONCERN. AT THAT TIME, EKLUND INDICATED THAT HE HAD WRITTEN OR WOULD WRITE TO
