Britain agrees with U.S. thinking on the matter of State Department cable 292469, except on its approach to the Soviet Union. Britain decided not to approach the Soviets because they were unsure whether Moscow's "commitment to nonproliferation outweighs their special political interests vis-à-vis Pakistan."

- CONTENTS OF REFERENCE PASSED TO ROBERT ALSTON, FCO, NOVEMBER 22. AFTER CONSULTATION, ALSTON REPORTED HMG AGREEMENT WITH PARAS (1), (3) AND (4).
- USG PROPOSALS RE SOVIETS IN PARA (2) GIVE HMG SOME CONCERN. HMG HAD REVIEWED POSSIBILITY OF AN APPROACH TO THE SOVIETS AT TIME OF THEIR DWN DEMARCHE ON THIS MATTER. DECISION WAS NEGATIVE ON GROUNDS THAT HMG NOT CERTAIN SOVIET'S COMMITTMENT TO NON-PROLIFERATION OUTWEIGHS THEIR SPECIAL POLITICAL INTERESTS VIS A VIS PAKISTAN.
- IN LIGHT OF ABOVE, ALSTON SUGGESTS THIS OUESTION BE DISCUSSED BETWEEN ALSTON AND AMB SMITH IN VIENNA, EITHER DURING NOVEMBER 26 BILATERAL OR IN PHIVATE SESSION. BREWSTER
