2. NOT CLEARLY EXPRESSED IN REFTEL COVERING MY MEETING WITH PAKISTANI PRESIDENT ZIA UL HAQ WAS THE PRESIDENT'S FINAL STATEMENT MADE TO ME IN PRESENCE OF AMBASSADOR SPIERS. HE SAID:

"GENERAL WALTERS, I AM AN HONORABLE MAN. WE ARE AN HONORABLE PEOPLE. I ASK YOU TO TELL YOUR PRESIDENT THAT I GIVE HIM MY WORD OF HONOR AS PRESIDENT OF PAKISTAN AND AS A SOLDIER THAT I AM NOT AND WILL NOT DEVELOP A NUCLEAR DEVICE OR WEAPON."
