Development of Russian Political Center

1. In the summer of 1950, the Department of State through Mr. George Kennan, who was then Counsellor of the Department, requested OIA/OPC to undertake the development of a political senter amongst the emigres from the Soviet Union which could speak to the Russians in the name of the Russians, At a number of conferences during August 1950 at the Department of State between representatives of State and OPC, the original concept of the operation was decided upon, and OPC received State Department approval and guidance to proceed the implement the project. One further major conference was held by Mr. Herthrop with Mr. Kennan at Primoston on 17 October 1950. Since that time, continuing guidance on important matters has been received from the Department, mainly through Mesars. Jayoe and Reinhardt.

2. The project as originally outlined had two major aspects:

a. The establighment of a cover committee in New York which would act as the estangible source of funds and guidance.

b. The organisation of a political center in Germany.

3. Certain general principles as to the organisation of the countities had been decided upon at the meetings with Mr. Kennan during the summer. The most important of these were:

a. That the center would be one of the peoples of Russia, including both Great Russian and non-Great Russian smigres.

b. That as soon as the political center was established, it would undertake certain concrete activities.

c. That our main interest in the project was reaching the people still within the Seviet Union and that our main interest in emigree was in using them as a vehicle for reaching the people inside.

d. That originally an attempt should be made to get four selected Great Russian groups tegether and that after this was done, certain non-Great Russian nationality groups, other Great Russian groups, and men-party individuals should be brought in. The four Great Russian groups were to be:

h. Certain general principles were also desided upon in relation to the establishment of the cover conmittee in New Yorks

a. That it should be a small committee.

b. That during the early stages of this project, publicity should be avoided. It was recognized that at some point in the future publicity would be necessary and desirable.

c. The Committee should in general be composed of prominent people who had a known interest or concern in Russian affairs.

d. That all the members of the consister should be "eut-dn" to the fact that this was a Government project.

e. That the consistee should be strictly a "front" and that at the outset this should be made very clear to them so that there would be no misunderstanding at a later date.

f. That the committee would not publicly solicit funds.

5. Sain January 1951, the organizational meeting of the conmittee took place at the River Club in New York attended by Mr. Misner and several other OFC representatives, and the following committee members:

> Rugene Lyons William H. Chamberlin Allen Grover William L. White William Y. Eliot

Fellowing this meeting, the committee was incorporated under the laws of the State of Delaware as a non-profit organization, with offices in New Yerk City, and was mamed "The American Committee for the Liberation of the Peoples of Russia, Inc." Fellowing this, office space was rented in New York and an effice set up under the direction of Reginald Townsend as Executive Director. At the present time, the office is securid by a small staff which is carrying on the routine business of the Counttee, covertly with Washington and covertly with the Counttee's representatives in Europe. Since its organization, two new members have been added to the Count tees Fermer Governor Markes Edison of New Jersey and Isaao Don Levine. At the present time, a Foundation is being established in the Midwest to act as one of the ostensible funds for the Count tees.

6. Upon the arrival of the original principal agent in Germany in the fall of 1950, negotiations took place with the four leading Bussian groups in an attempt to get agreement for the establishment of a political center. In January at Fuessen, Havaria, a meeting of these four groups took place. The meeting was unsuccessful because of failure to reach an agreement on two basis issues:

a. The admission of non-Great Russian nationalities to the political center on a basis of equality.

b. The failure to agree on the handling of the difficult question of the future government in Russia following the downfall of the present regime.

The Committee took the position:

a. That the non-Great Russian nationality groups which accepted the basic program of the political center must be admitted on the basis of equality.

b. That the issue of the future government for Russia should be decided by <u>self-determination</u> at such a time as the people could freely express their will.

Following the break-up of the conference, negotiations proceeded with the four main groups individually.

7. In April 1951, it was desided that a new European Representative of the Countties, asting as our principal agent in Germany, was necessary.

presented immediately to Cernany to make assurvey. Following a repid survey involving individual discussions with the various groups and certain minority groups, he returned to the U. S. and reported to us. It was agreed that _______ should return to Germany as the permanent European Representative of the Committee for at least a year-and-a-half and that as quickly as pencible another attempt should be made to reach an agreement smong the four Great Eussian parties.

returned to Europe in early July and continued his individual negotiations with each of these four groups and with certain non-Great Russian minerity groups. From 17 to 20 August 1951, a second meeting took place in Germany. (As a result of the split in the New York League, the number of Great Russian groups had grown from 4 to 5, the new group being the Russian Peoples Movement (Maroduiki.) These five groups met in Stuttgart and on 20 August reached an agreement on a protocol which was signed by two members from each group. The protocol will form the basis of the political center. The five parties adcepted the two points which the Consultee insisted on at Fuessen. At a press conference in Frankfurt on 21 August, an announcement was made of this agreement. The political center will be known as the Gouncil for the Edberation of the Peoples of Russia. A press conference was held in New York on 22 August by Mr. Lyons, President of the Gounittee, to give out further details to the American Press.

8. During the last few months, planning has been proceeding and certain action has been taken in regard to the "practical work" which the political center will undertake, which is of course the real purpose of the whole project. The major elements in this "practical work" are the following:

- a. Radio programs beamed at the Soviet Union
- b. A newspaper
- g. Political activities of the Center
- d. Research Institute in Germany

9. Last spring, the New York cover generities took over support of the Russian Research Institute in Numich and has since that time been strengthening and expending its activities. This Institute will now become part of the political center. In addition to this, planning has been going forward for the other activities.

work on the establishment of the newspaper will get under way almost immediately. A Russian editor for the paper has already been selected. The five Great Russian parties have established an organization bureau to which non-Great Russian nationality representatives will soon be added which will direct the various activities of the political center from the Russian side,

10. The largest and most difficult problem is that of establishing the radio facilities and programming necessary for large-scale broadcasts to the Seviet Union. A study has been prepared for us by A. D. Ring & Co. covering the basic technical factors involved in shortwave broadcasting to the Soviet Union and outlining the preferable areas for the location of radio transmitters.

11. Now that the agreement has been reached to form the political center and the preliminary planning and collection of information has been completed, certain basic decisions must be made in regard to the radio projects

b. Firm and final approval of the Department of State and GIA must be given to the establishment of radio transmitters to be used by the political center for broadcasts to the Soviet Union.

c. A decision must be made as to where to locate the transmitters and the Department of Stade's approval and assistance must be granted to the Committee to enable it to approach the Covernment in that area.
