1. This memorandum suggests action by the DCL. The ted action is contained in paragraph 3.

2. On : 24 January 1957 Mg. Bakings forwarded to the Dig a paper entitle a Reappraisal of U. S. P repayands Broadsmoth This paper was designed to assist the P drector in reciving to Mr. Robert Murphy on a State Departme-at paper bearing the same title. The first paragraph of our paper sugarented the formation of a new working group composed of State. CIA | post USIA. This suggestion has been discussed informally with 1 Mr. Reams' office in State and with Mr. Robert Button (Chief of V OA and Chairman of the ... 5 committee on Broadcasting and Television). It has their ends seement in principle and their agreem ont that the working group should be limited in number and composed of individuals senter enough to contribute to important decistions. It is generally agreed that I'me most appropriate chairman would be Mr. E. Allan Lightner Jr. and that the other Department of Strite representative should be Mr. Robert Reams. On the same masts it is envisaged that the CIA repropentatives would be Mr. Dosmond FitsGerald and Mr. Cord Moy ig or their respective deputies.

The USIA representatives would be

M.r. Andrew Berding or Mr. Alfred Boerner, and Mr. Button for VOA. Although initially the membership would be limited to these three agencies, it is considered advisable to put the working group

within the OCB structure. The OCB Committee on Areadvasting and Television (COBAT) would continue in entrance but would concentrate on television matters and on details of radio broadcasting that do not require the major reappraisals that will be considered by the special ad her working group.

J. It is recommended that the Director emphasize the advisability of the formation of this small and select ad her working group for the reappraisal of breadcasting and, in particular, obtain Mr. Murphy's concurrence to the designation of Mr. E. Alian Lightner Jr. as chairman of the group.
