SPECIAL HANDLING

SITUATION HERE TENSE AND EXTREMELY DIFFICULT TO ASSESS AS GREAT PRESSURES CLEARLY BEING APPLIED ON PARTY CONGRESS WHICH NOW DEPRIVED OF ITS LEADERSHIP. MEANTIME YOUTH WHO ARE ANGERED BY REPORTS OF SOVIET TREATMENT OF LEADERS ARE GETTING RESTIVE AND SOVIETS NERVIOUS. EXTREME CAUTION CALLED FOR IN MEDIA REPORTING OF EVENTS. ANYTHING READ AS ENCOURGEMENT TO YOUTH COULD CREATE SITUATION PUTTING ADDITIONAL HEAVY PRESSURES ON REMAINING PARTY LEADERS WHILE DISCOURAGEMENT COULD BE INTERPRETED AS LACK OF SUPPORT. MEDIA SHOULD MAINTAIN POLICY OF RAPID REPORTING OF NEWS AND PRESS COMMENTS WITH FULL ATTRIBUTION TO SOURCES ESPECIALLY IN CASES WHERE REPORTS VAGUE AS TO PRECISE FACTS.
