**Summary:**

Van Schelle reports that pending the outcome of an investigation the Belgian government has told its Embassy in Warsaw to avoid further contacts with the North Koreans. Furthermore the Belgian Embassy in Bern will look into a presumable visit to Switzerland by a highly placed North Korean and possible motivation of the Swiss to establish a North Korean trade office. The Belgians have reiterated their restrictive standpoint and have no current intention to recognize North Korea

**RELEASE OF PROCESSES DEVELOPED BY THE NATIONAL LABORATORIES**

\*520. SHRI SHYAMLAL GUPTA : Will the Minister of INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY be pleased to state :

(a) the present procedure followed in the release of processes developed by the National Laboratories;

(b) whether there is any lacuna in the present procedure, if so, whether Government contemplates to effect certain changes in the existing procedure; and

(c) if so, the details thereof ?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND SCIENCE AND TECHNOLOGY (SHRI C. SUBRAMANIAM) : (a) The processes developed by National Laboratories are normally released through the National Research Development Corporation of India (NRDC) under an agreement between CSIR and NRDC.

(b) The present procedure needs to be modified in respect of evaluation of processes/patents/know-how emanating from the National Laboratories.

(c) According to one proposed change, the processes will be evaluated by a single techno-economic group, jointly agreed to by the CSIR and NRDC, prior to its commercialisation through the NRDC of India.

**SHORTAGE OF CINEMA HOUSES**

\*521. SHRIMATI PRATIBHA SINGH : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether it is a fact that in a number of cases good films have to wait for a long time for being screened and exhibited due to shortage of the cinema houses in the country;

(b) how the average population to be catered by a cinema house in India compares with that in France, USA, UK, USSR and Japan; and

(c) whether any comprehensive national programme for construction of cinema houses is proposed to be launched during the 5th Five Year Plan, if so, the details of the programme, and the estimated cost of the programme and whether a certain

percentage of cinema houses are to be constructed in the public sector; if so, the details in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI I. K. GURAL) :

(a) Yes, Sir.

(b) The following are the comparative figures for 1970 :

| Country          | No. of cinemas | Seats per 100 |
|------------------|----------------|---------------|
| France . . . . . | 4,358          | 4.2           |
| U.S.A. . . . .   | 14,420         | 4.9           |
| U.K. . . . .     | 1,529          | 2.6           |
| U.S.S.R. . . . . | 157,000        | Not available |
| Japan . . . . .  | 3,246          | 1.4           |
| India . . . . .  | 7,140          | 0.8           |

(c) Cinema is a State subject. One of the recommendations adopted at the Conference of the State Ministers of Information held in New Delhi on December 8, 1972, was that the States should divert a fixed proportion of collections from entertainment tax for promoting the construction of more cinemas.
