- 3. On recently of this petition it was passed by Eszelboff to
  New York. At Bernie Yarrow's suggestion in the absence of Archie
  Alexander who was in Liebon the beni of the
  Caschoslovak Deak in New York, called some members of the Caschoslovak
  Deak in Manich and obtained their agreement to withdraw the petition.
- i. Sazelboff, however, felt that this was not sufficient and issued a measurandom to the Czechoslovak Deak in Munich to the effect that if each member did not issue a full retraction as specified in his memorandom, he would issue termination notices to each person involved by 2:00 p.m., Munich time, November 22.
- 5. Three members of the 19 signed the retraction, the remaining 16 refused. At 2:05 p.m., Hovember 22, these 16 were issued termination notices by Heselhoff.
- 6. Although we do not have the manes of the people involved, we are told that these is are the key people on the Desk. We are also told that the other Crecks and Alovaka in Manich have "associated" these with these who refuse to sign the petition. Potoker, the representative of the newspaper guild to which practically all members of the Creck Desk in Kamich belong, has interested bimself in the case and has instructed his members not to sign the retraction. Rows and Rodney Smith to Munich on November 26 with \_\_\_\_\_\_\_\_ to follow if needed. Alexander is distanted that Reselborf took what he considers to be precipitous action after the initial petition had been withdrawn. Alexander is also disturbed about what will containly be at least local publicity about this in Germany and the repercussion of this within RFS generally.

- 3. This problem is somethet complicated by the fact that two of the senior appointees on the Casch Dook are considered to be security risks (Granek and Balak-Berger). There is considerable question as to Whether \_\_\_\_\_\_ is qualified to run the Dook and it is probable that some major reorganization of the Peck will have to be worked out.
