SOUTH AFRICAN NUCLEAR INTENTIONS.

FOLLOWING IS TEXT OF MY LETTER TO BOTHA DATED 20 AUGUST.

BEGINS.

I HAVE BEEN INFORMED BY MY AMERICAN COLLEAGUE OF THE EXCHANGES
HAS HAD WITH YOU CONCERNING RECENT PUBLIC ALLEGATIONS THAT THE
SOUTH AFRICAN NUCLEAR PROGRAMME IS NOT DEVOTED EXCLUSIVELY
PEACEFUL PURPOSES.

MY SECRETARY OF STATE ATTACHES SO MUCH IMPORTANCE TO THIS
MATTER THAT HE INSTRUCTED ME TO RETURN TO SOUTH AFRICA AHEAD
MY PLANNED SCHEDULE IN ORDER TO RAISE IT WITH YOU. DR OWEN
HAS ASKED ME TO POINT OUT URGENTLY THAT IN THE VIEW OF HER
Majesty's GOVERNMENT THE CONSEQUENCES WOULD BE DISASTROUS TO THE
CHANCES OF ACHIEVING PEACEFUL SOLUTIONS FOR THE PROBLEMS OF
SOUTHERN AFRICA, IF SOUTH AFRICA WERE TO PRODUCE, AND STILL MORE
TEST, A NUCLEAR DEVICE. IT WOULD BE HARD TO IMAGINE AN ISSUE
WITH GRAVER IMPLICATIONS. SECURITY COUNCIL ACTION COULD WELL
BE CALLED FOR IMMEDIATELY, WITH ALL THAT WOULD ENTAIL.

THE BRITISH GOVERNMENT ACCORDINGLY URGE THE SOUTH AFRICAN
GOVERNMENT TO GIVE IMMEDIATE AND CONVINCING PROOF THAT THEY
HAVE NO SUCH PLANS, IN ORDER TO ALLAY WIDESPREAD AND GENUINE
INTERNATIONAL ANXIETY. IN THIS CONNECTION THEY WISH TO REPEAT

THEIR STRONG ADVICE THAT SOUTH AFRICA SHOULD ACCEDE TO THE
 NON-PROLIFERATION TREATY WITHOUT FURTHER DELAY.
 SINCE YOU ARE AT PRESENT IN CAPE TOWN I AM TRANSMITTING
 THIS LETTER THROUGH MR FOURIE IN PRETORIA. I HAVE MADE IT CLEAR
 TO HIM, HOWEVER, THAT I AM ENTIRELY AT YOUR DISPOSAL TO TRAVEL
 TO CAPE TOWN SHOULD YOU THINK A PERSONAL DISCUSSION DESIRABLE.
 ENDS.
