In my letter ER 1241/21/G of June 22 I said that the D.I.S. had passed the information about the alleged supply of Argentine uranium concentrate to Israel (on which my letter of April 29 was based) to the Americans. The D.I.S. have now told us that the Americans are highly sceptical ^{about the report}. According to their sources no agreement has been signed between Argentina and Israel, if it had, the agreement would have been reported in the official bulletin. The Americans pointed out that in January 1963 the Argentine Atomic Energy Commission received authorisation to export 100 tons of uranium concentrate but say that to date no country has purchased any of this. This, of course, contradicts the ^{Canadian} information in para 1 of your letter 1244/64/G of June 4. ^{if you can get anything more on this, we should be very grateful}

2. In view of the now ~~very~~ dubious authenticity of the original report I think that there would be little point in passing on the information to the French as Peter Ramsbotham proposed in his letter to Willie Morris 1247/16/64 of June 11 (not copied to you or Bonn).

3. I am copying this letter to Kellas in Tel Aviv, Maitland in Cairo, Ramsbotham in Paris, Miss Warburton in Bonn (with reference to her letter of 10644/129 of July 2 to Robin McLaren), Arkell in the Defence Intelligence Staff and Redpath in the C.R.O.

In my letter ER 1241/21/G of June 22 I said that the D.I.S. had passed the information about the alleged supply of Argentine uranium concentrate to Israel (on which my letter of April 29 was based) to the Americans. The D.I.S. have now told us that the Americans are highly sceptical about the report. According to their sources no agreement has been signed between Argentina and Israel; if it had the agreement would have been reported in the Official Bulletin. The Americans point out that in January 1963 the Argentine Atomic Energy Commission received authorisation to export 100 tons of uranium concentrate but say that to date no country has purchased any of this. This, of course, contradicts the Canadian information in paragraph 1 of your letter 1244/64/G of June 4. If you can get anything more on this, we should be very grateful.

2. In view of the now dubious authenticity of the original report I think that there would be little point in passing on the information to the French as Peter Ramsbotham proposed in his letter to Willie Morris 1247/16/64 of June 11 (not copied to you or Bonn).

3. I am copying this letter to Kellas in Tel Aviv, Maitland in Cairo, Ramsbotham in Paris, Wright in Washington, Miss Warburton in Bonn (with reference to her letter 10644/120 of July 2 to Robin McLaren), Arsell in the Defence Intelligence Staff and Redpath in the Commonwealth Relations Office.
