Summary:

After consulting the Defense Intelligence Staff, Goodison writes to Kellas that "we must now accept the end of 1968 as the earliest possible date" for an Israeli nuclear bomb. As the Canadian report suggested an Israeli test by 1966, either 1968 was a typo or the Defense Intelligence Staff provided more detailed comments than are available in the file.

Thank you for your letter 1242/64G of October 8 about nuclear development in Israel.

2. We consulted the Defence Intelligence Staff about the Canadian DSI paper 1/64. They agreed that the paper was well organised, made the most of the basic material available and, as far as they could see, left none outstanding. They agreed with what was said and with the conclusions. They added that such differences as there might be between them and the Canadians would only be in shade and not in matter or conclusions and were not therefore worth dwelling on.

3. In the light of their comments, the reservations which we have had here about the date by which the Israelis could produce a nuclear bomb would no longer seem to be valid, and we must now accept the end of 1968 as the earliest possible date.

4. I have been asked by the D.I.S. to draw your attention to the fact that the Canadian paper and any correspondence based on it must, for the time being at any rate, remain classified Secret and Canadian/U.K. eyes only.
