Letter dated 14 November 1970 from the Permanent Representative of Chile to the United Nations addressed to the Secretary-General

After giving careful consideration to all aspects of the problem of the unification of Korea, my Government has instructed me to inform you of its decision to withdraw from the United Nations Commission for the Unification and Rehabilitation of Korea. My Government does not desire that its decision should necessarily be considered an expression of criticism of the Commission's activities, but it wishes to be in a position to explore other possibilities for action which might signify a worth-while and disinterested contribution to the cause of peace in that area.

I shall be grateful if you will inform the General Assembly of the aforementioned decision, in order that any appropriate action on it may be taken at the current session.

SUBJECT: Communication from the Permanent Representative of Chile OBJET to the Secretary-General dated 14 November 1970 regarding UNCURK.

The following minute is to serve as a record for the file.

1. At 2:15 p.m. today, Mr. Fernando Zegers Santa Cruz came to my office to present me with the above mentioned communication (copy attached) announcing the decision of the Government of Chile to withdraw from UNCURK.

I informed him that I dealt with administrative matters 2. of UNCURK and that this communication should normally be handled by Mr. Narasimhan.

3. After having called the Secretary-General's Office, and having Mr. Kehlhofer personally check the 38th floor, it was found that no one was present there.

In order not to delay the Deputy Permanent Representative, Mr. Zegers, I minuted a copy of the communication, stating that I had received it on behalf of the Secretary-General.

After having called you at 2:30 p.m., I attempted to reach Mr. Narasimhan by telephone at his home, but he was not in. I was able then to reach Mr. Sivasankar at his home, and it was agreed to hold the communication in my office until Monday, but to send a code cable to Mr. Kuzbari in Seoul, the text of which was agreed upon over the telephone and sent immediately thereafter.
