The United Nations just started its 32nd General Assembly Session.

2 years ago, the U.N. adopted the resolution "On Creating Favourable Conditions for Converting the Armistice into a Durable Peace in Korea and Expediting Independent Peaceful Reunification of Korea" and announced it to the whole world.

The resolution pointed out to dissolve the "UN command" and to withdraw all the foreign troops stationing in south Korea under the UN flag, and appealed to the real parties concerned of the armistice agreement to replace the Korean Military Armistice Agreement with a peace agreement.

The resolution also demanded to remove the state of military confrontation in Korea, to maintain durable peace and to accelerate the independent peaceful reunification of Korea.

Though a long period of 2 years already passed since the adoption of this resolution, none of its contents was put into practice. It is none other than the United States to implement this resolution as the party directly concerned. Notwithstanding this, that the United States did so far was the acts which goes contrary to this resolution.

The United States did not dissolve the "UN command" that it has used as a tool for its aggression, but it goes the length of openly declaring to continuously maintain the "UN command", trampling underfoot the UN resolution.

It was stipulated in the UN General Assembly resolution to withdraw all the foreign troops from south Korea, but the

United States intensifies war preparations behind the smoke-screen of the "ground troops withdrawal by stage" and declared that it will further reinforce its air forces and navies in south Korea, thus overtly challenging not only the Korean people but also the peace-loving peoples of the world.

In stead of exerting efforts to remove the state of military confrontation, to bring about durable peace in Korea and to hasten the independent peaceful reunification in Korea, the United States renders huge amount of military aid much more than ever to south Korea, clamouring about the fictitious "danger of southward invasion", "balance of power" and the like, thereby, aggravating tension in Korea.

The United States must withdraw at once its aggression troops from south Korea, accept the proposal to replace the Korean Armistice Agreement with a peace agreement and should not do any acts hampering Korea's reunification in accordance with the resolution of the 30th Session of the UN General Assembly and in conformity with the spirit of the UN Charter on non-interference in the internal affairs of the others.

The United States will not be able to avoid severe punishment of the history, if it continuously clings to the aggression on and interference into the internal affairs of other countries, retrogressing against the current of the times.
