#### NEWSPAPER FINANCE CORPORATION

656. SHRI INDER SINGH: Will the Minister of INFORMATION AND BROADCASTING be pleased to state the progress so far made in respect of proposal to establish Newspaper Finance Corporation?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINGH): Certain modifications of the original Bill are under the consideration of Government, A revised Bill is expected to be introduced as soon as possible.

#### NUCLEAR EXPLOSIONS BY CHINA

657. SHRI VENIGALLA SATYA-NARAYANA: Will the Minister of ATOMIC ENERGY be pleased to state:

- (a) the number of nuclear explosions made by China which were recorded in the explosion detective system of our country during the last three years; and
- (b) whether Government propose to increase the efficiency of our centres in recording nuclear explosions including underground explosions in different parts of the world?

THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRIMATI INDIRA GANDHI): (a) Four.

(b) The Government is constantly reviewing the possibilities of increasing the efficiency of our centres of detecting nuclear explosions including underground explosions. At the present moment there is no proposal for any large scale expansion of these centres as it is felt that

these are quite capable of recording nuclear explosions in different parts of the world.

#### INDUSTRIAL LICENCES

658. SHRI VENIGALLA SAFYA-NARAYANA: Will the Minister of INDUSTRIAL DEVELOPMENT be pleased to state the number of industrial licences issued during the last three years and the number of licences which have been utilized?

THE DEPUTY MINISTER IN THE MINISTRY OF INDSUTRIAL DEVELOPMENT (PROF. SIDDHESHWAR PRASAD): 221, 363 and 625 industrial licences were issued during 1969, 1970 and 1971 respectively. It can be said on the basis of practical experience gained in the past that most of the licences issued take three to four years to be fully implemented. These licences are, therefore, at various stages of implementation.

- (a) the number of permanent class IV employees transferred to the Central Hindi Directorate, Ministry of Education by the Central Bureau of Translation, Ministry of Home Affairs in December, 1971;
- (b) whether it is a fact that these empployees have not so far been taken on duty by the Central Hindi Directorate and they have not been paid their salaries since December, 1971, and
- (c) if so, the reaction of Government thereto?]

गृह मंत्रालय में राज्य मंत्री (श्री राम निवास मिर्घा): (क) एक स्थानापन्न दफ्तरी को स्वय उसके अनुरोध पर केन्द्रीय हिन्दी निदेशालय से स्थानान्तरित किया गया था।

(स) और (ग) इस सम्बन्ध मे केन्द्रीय हिन्दी निदेशालय के साथ लम्बा पत्र-ज्यवहार हुआ है जिसने दफ्तरी को इस आधार पर कार्यग्रहण करने की अनुमति नहीं दी थी कि उसे उसके पद के साथ केन्द्रीय अनुवाद ब्यूरों को स्थानातरित किया गया था और उसका निदेशालय में वापिस आने का कोई प्रथन नहीं था । मामले पर कार्मिक विभाग के साथ परामशं में विचार किया गया था और दफ्तरी को केन्द्रीय अनुवाद ब्यूरों में कार्यग्रहण करने को कहा गया है।
