Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) what is the Government's stand with respect to the proposed treaty on non-proliferation of nuclear weapons; and

(b) what is the reaction of the big powers thereto?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI M. C. CHAGLA):  
(a) The Government of India considers that the treaty on non-proliferation of nuclear weapons should conform to the principles set out in U.N. General Assembly Resolution 2028(XX), viz.,

(i) The treaty should be void of any loop-holes which might permit nuclear or non-nuclear Powers to proliferate, directly or indirectly, nuclear weapons in any form;

(ii) The treaty should embody an acceptable balance of mutual responsibilities and obligations of the nuclear and non-nuclear Powers;

(iii) The Treaty should be a step towards the achievement of general and complete disarmament and, more particularly, nuclear disarmament;

(iv) There should be acceptable and workable provisions to ensure the effectiveness of the treaty;

(v) Nothing in the treaty should adversely effect the right of any group of States to conclude regional treaties in order to ensure the total absence of nuclear weapons in their respective territories.

It also considers that the treaty should be comprehensive and non-discriminatory, and that it should not impede the development of nuclear energy for peaceful purposes.

(b) The USA and the USSR have been consulting each other to produce a draft treaty but have not yet reached agreement on a mutually acceptable draft.
