†[THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) Yes, Sir.

(b) The book deals with the events of 1962 and gives the personal opinion of the author regarding the blame to be apportioned to various persons and certain measures and attitudes to be taken up to deal with the aftermath. These events have been exhaustively debated in the House on several occasions and the Government reaction has been adequately explained in the comprehensive statement made by the Defence Minister on 2nd September, 1963. The House is also aware generally of the action being taken to keep the defence forces in a state of preparedness to deal with eventualities.]

SECURITY COUNCIL'S ASSISTANCE TO NON-NUCLEAR STATES

*594. SHRI M. R. VENKATA-RAMAN: Will the PRIME MINISTER be pleased to state:

- (a) whether Government's attention has been drawn to the declaration of the United States of America. U.S.S.R., and the United Kingdom asking the Security Council for taking immediate action to assist any non-nuclear State against which nuclear aggression is committed or threatened; and
- (b) if so, what is the reaction of the Government of India thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT): (a) Government are aware of the unilateral declarations made by the three Governments of their intention to seek immediate Security Council action in the matter.

(b) Government welcomes these declarations. However, it is the primary responsibility of the Security Council to maintain international peace and security, and to meet threats or acts of aggression. The responsibility and obligation of the

Indeed, it has been the view of the Government that the signing of the Non-Proliferation Treaty does not, in any way, derogate from the obligations of the Charter and the special responsibility of the Permanent Members of the Security Council for the maintenance of peace and security.

- (a) what was the number of Naga hostiles killed or captured in the clash with the Indian security forces at Jetsomah village (Kohima, Nagaland) in June, 1968 and what was the value of property seized by the Indian forces;
- (b) what are the details of the Indian patrol party personnel who were killed and what was the extent of loss suffered?]
