JAPANESE PROPOSAL ON DETAINSES IN OMURA AND PUSAN AS OF DEC. 27, 1955

- 1. The Government of the Republic of Korea will release without delay ( ) Japanese fishermen interned in the Aliens' Reputriates Camp in Korea as of December 31, 1955.
- 2. The Government of Japan will release on parole ( ) criminals who are Koreans residing in Japan, who have been ordered for deportation as of December 31, 1955 and who are under detention in the Immigrants Camp, in accordance with provisions of the Immigration Control Order.

70 persons will be released on parole each month.

3. The Government of the Republic of Korea will receive those persons who entered Japan illegally after the termination of the War and those who entered Japan legally after the termination of (1) the War but have been already ordered or will be ordered hereafter for deportation, in accordance with provisions of the Immigration Control Order.

(Footnote 1: ( ) persons as of December 31, 1955)

As for persons who have been already ordered for deportation will be repatriated twice a month, each time by a single repatriation ship to be boarded by 250 persons.

As for persons who will be ordered hereafter for deportation, they will be repatriated as a rule once a month, each by a single repatriation ship to be boarded by 250 persons.

- 4. The Governments of Japan and the Republic of Korea will promptly have a talk in respect of provisional rules to be applied for deportation to the Republic of Korea of the Koreans who have resided in Japan since and before the termination of the war. It is intended that the above talk will reach an understanding at least before the end of February, 1956.
- 5. Even before the understanding to be reached in the preceding paragraph, the Government of the Republic of Korea will accord humanitarian treatment toward crew members of the captured Japanese fishing boats and the Government of Japan toward Koreans who are criminals under detention in the Immigration Camp.
